C.I.Agent is pre-authorized by the U.S. EPA as a "**1st Response Product**" for a treatment volume of less than 500 gallons of oil in Federal Region IV (North Carolina, South Carolina, Georgia, Florida, Alabama, Mississippi, Tennessee, and the Commonwealth of Kentucky). Up to 1,000 pounds (lbs.) of "loose product" can be applied directly to the water per each recovery effort as long a complete recovery of C.I.Agent is accomplished. There is no restriction on the amount of C.I.Agent applied when it is in a "contained" form (booms, bags, filters).

The recovery efficiency of C.I.Agent Solutions' Products is excellent; the "**contained**" products are **reusable** and finally when disposal is needed, the associated disposal costs are significantly lower than those for "hazardous wastes".
